2.0 INTRODUCTION / SCOPE OF WORK

We propose to provide landscape architectural services to the City of Oxnard that will ultimately produce a successful park. In other words, a park that contains quality elements and facilities that the public and the Parks staff want. A park that is safe and enjoyed and utilized by many. A park that is easy to maintain and sustainable.

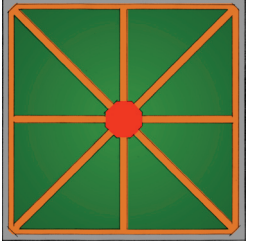
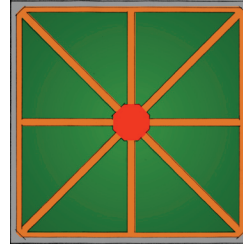
Our extensive knowledge of products and services, along with good design technique, will allow the City to obtain as many elements and facilities within a budget as possible. The plans and specifications will be clear and concise, in order to attract good contractors and to keep change orders and problems during construction to a minimum. We want the park to be designed and constructed within a reasonable time at a reasonable cost. Our track record shows that we can provide services that will ensure, as much as possible, that that happens.

Doug Bungert is very familiar with this project. He designed the first phase several years ago, when he worked for the City as Landscape Architect. Doug is also very familiar with the permit process at the City, County and State.

Our understanding from the City's RFP is that it wishes to improve the site by adding a restroom building(s), a concession building, soccer fields, parking lot and lighting, automatic irrigation system and landscaping.

The City has defined the Landscape Architectural Services Scope of Work in its RFP to include the following: prepare and distribute meeting minutes; obtain approval of permits; provide design services; expedite plans through permitting agencies; provide quality control; provide cost evaluations for each milestone; provide constructability analyses; review RFIs, material submittals and shop drawings; maintain good records; provide schedules of tasks for design and construction; schedule meetings with the City; provide value engineering recommendations; and communicate frequently with the City and consultants.

The primary tasks required to carry out the Scope of Work will be as follows:

1. **Pre-Design Phase.** This is the data collection and analysis phase. We will search for existing documents from the City, and the County, etc. that will have an impact on the design. We will identify the stakeholders, meet with them and list all their wishes and needs. Stakeholders will include the citizens, league officials, Parks and Recreation staffs, and the Board. All of the obtained information will be analyzed and synthesized.

2. **Design Phase.** This is where the written and verbal data is made into graphic, visual form. Several drawings will be generated by our office in order for the stakeholders to “see” their wishes on paper, and evaluate whether they are realistically attainable. Several renditions of Conceptual Plans may be produced. Plans and all the park elements will be presented. Several meetings and presentations will take place and our office will facilitate these meetings.

Our office will generate Construction Cost Opinions. Decisions will be made regarding how much is affordable to design and construct within the budget. Decisions will be made about phasing the project, if necessary. More meetings will take place with City Staff, which our office will facilitate. Public meetings may also take place. Several alternatives will be looked at, and finally, our office and City Staff will decide the appropriate design path to pursue.

Construction Drawing Phase: We will assign tasks to our subconsultants and manage the design and engineering of the civil engineers (topographical studies and survey, grading and drainage, utility design, parking lot design), the architects (major structures and related structural, electrical, mechanical, plumbing, and utilities engineering), and the electrical engineers (site, parking lot and ballfield lights). Our office will produce hardscape, planting, irrigation and site furnishing plans, specifications and details.

Plan Approval Phase: Our office will submit Construction Documents to the City and other agencies as required for approval. We will make any plan check corrections that are

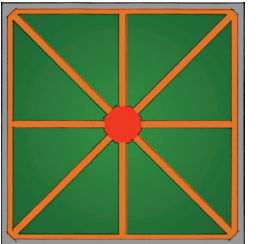
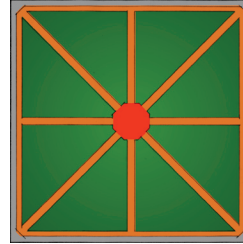
necessary and resubmit as necessary until plans are approved.

Bid Administration Phase: Our office will be available to the City throughout this phase for attending meetings, pre-bid meetings, evaluating construction bids, etc.

Pre-Construction Phase: Our office will be available to conduct Pre-Construction Meetings with the City, the Contractor, and labor compliance representatives. We will review contractor submittals.

Construction Phase: Our office will attend meetings with City Personnel, City Inspectors. And Contractor. We will conduct on- site and office meetings. Our firm will observe and inspect the work of the project and write reports and take minutes of meetings. We will review payment requests.

Post Construction Phase: Our office will continue to observe and inspect during the plant establishment phase, write reports, and conduct meetings with City personnel until final payment has been released to the Contractor.

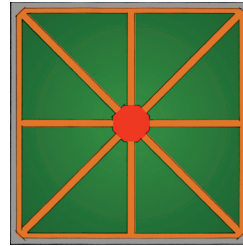
A few brief notes of clarification:
